



**REESE'S GO FOR TWO FIRE DRILL PROMOTION ("Promotion")
OFFICIAL RULES**

1. HOW TO PLAY: NO PURCHASE NECESSARY TO PARTICIPATE IN

PROMOTION. During the Promotion Period, there will be twenty-eight (28) individual promotional giveaways (each a "Fire Drill") as set forth in the chart in Section 2 below. The Hershey Company ("Sponsor") will determine the specific start time for each Fire Drill and will send out a public notification on Twitter that will include a link for participation ("Website"). Each Fire Drill will conclude after all prizes have been awarded for that particular Fire Drill. To enter, entrants must click on the link to access the Website to participate in the Fire Drill. Entrants must enter his/her e-mail address to participate during each Fire Drill. If it is the entrant's first time entering the Promotion, he/she will also be required to complete the registration form which will include first name, last name (no initials), mailing address (no PO Boxes), city, state, zip code, and phone number. Once entered, the entrant will be notified if he/she is a winner (a "Play"). For purposes of this Promotion, an entrant's e-mail address will be the e-mail address submitted at the time of entry for the first Fire Drill. Entrants will not be allowed to change their e-mail address. For each Fire Drill, the quantity and type of prizes to be awarded are set forth in Section 2 below.
